#### *Ring 2 Information:*

A second ring will be available on Sunday 9th December with two clear round heights built free of charge for any riders wishing to ride in this starting at 9am. This ring will be open to Canberra Lakes Pony Club members and other riders of the Emmaville Show sponsored by Emmaville Performance Horses and Forest Park Riding School. If riders wish to ride in these classes a liability waiver must be signed and provided before riding to either Kate Mackenzie if you are with Pony Club or otherwise to the commentary area if you are not a Pony Club member. Waivers are available through the Forest Park Riding School website or in the documents section of Global Entries. *No ribbons for ring 2 as this will be a clear round ring.*

## SHOW INFORMATION

---

- All riders must fill out a waiver indemnity form before riding through Global Entries for Ring 1 or a paper copy for Ring 2
- Horses may compete in a maximum of two (2) Showjumping events and one (1) six bar each day
- Horses may only compete in each event once
- No refund after entries close
- Changes to start times may occur depending on rider numbers and weather – if changes occur notification will be provided through the Emmaville Facebook page and the website
- Dogs must be on leads at all times. No dogs to be in the main jumping arena at any time
- In the case of unsafe weather conditions, please see the Emmaville Performance Horses websites or Facebook pages and emails for updates
- The Coffee 'n' Snack Shack will be present to supply quality food and drink during the competition
